I HEREBY AGREE that by signing this DIRTcar RACING Membership & Competition License Indemnity/Release "Membership Application" that I will abide by all rules and regulations as set forth by DIRTcar RACING including, but not limited to, the following:

(1) I agree to abide by all rules and regulations as may be amended from time to time, including car specifications and safety rules;

(2) I certify that I am not an agent of World Racing Group Inc., World of Outlaws or DIRTcar RACING and that I will not become an agent of DIRTcar RACING as a result of DIRTcar RACING'S approval of my application. I further certify that, with respect to any activities in which I engage as a member and licensee of DIRTcar RACING, I am either an independent contractor or an employee of another person or entity. Therefore, I assume all responsibility either by myself or my employer, for any charges, record keeping, premiums and taxes, if any, payable on any funds I may receive as a result of my activities as a DIRTcar member and licensee, including but not limited to, social security taxes, unemployment insurance taxes, workers compensation insurance, income taxes and withholding taxes;

I also understand that there are natural, mechanical, and environmental conditions and risks which independently or in combination with the activities may cause property damages or severe or even fatal injuries to me or others.
